GENERAL SESSION, TUESDAY, SEPTEMBER 10, 2013

The 86th Annual State Conference was called to order by President Cathy Hanzik at 2:35 p.m. at the San Marcos Conference Center.

The Invocation was given by Deacon Lou Endris of St. John's Catholic Church in San Marcos. The Presentation of Colors was by the Air force JROTC from San Marcos High School. The Pledge of Allegiance to the U.S. Flag was led by Edith Jones, District 6 Director. followed by the singing of "God Bless America". The Pledge to the Texas Flag was led by Edith Jones, followed by the singing of "Texas, Our Texas". The song leader was Rayanne Bowker of District 5. Martha Crawford, District 7 Director, led the reciting of the TEEA Creed and Mission, followed by the singing of the TEEA State Song - "Song of Peace". Welcome by the West Region was given by Una Kunkel, District 10 Director. Welcome to San Marcos was given by the Honorable Wayne Becak, Deputy Mayor Pro Tem of San Marcos.

The Credentials Report was given by Carrol Davig, District 11 Director:

The Credentials Report was adopted. A quorum was established.

Secretary Julie Neusch, read the Rules of Conference, which were adopted by the assembly. The Conference Program was reviewed by Julie Neusch, with necessary changes made. The Conference Program was adopted as the order of business.

Delegate Responsibilities were reviewed by Julie Neusch.

President Cathy Hanzik introduced members of the host districts, 6, 7 & 10, and the 2012-2013 Board of Directors. Then she introduced the past TEEA Presidents who were present, and all past State TEEA Board members were recognized.

Dr. Judy Warren spoke about the Texas A&M AgriLife Extension Service, then introduced Extension Personnel in attendance. Dr. Warren then introduced Dr. Douglas L. Steele, Director of Texas A&M AgriLife Extension Service, who spoke about the partnership between TEEA & the Extension Service. The Memorandum of Agreement was signed by Dr. Steele & Cathy Hanzik.

First Vice President for Leadership Julia Moseley introduced each District Director as they announced their Outstanding Education Counties and Honor Roll of Counties, and awarded certificates. (Att. 2)

President Cathy Hanzik presented Dr. Steele with two "Big Checks" representing the value of education, volunteer hours and scholarships given by members last year. The checks were in the amounts of \$105,920.00 for education reaching 15,234 people; and \$5,394,572.00 for 244,041 volunteer hours plus scholarships.

Cathy Hanzik recognized 53 first-time attendees.

The Texas Treasure Award district winners & state nominees were introduced. The winner of the State TEEA Texas Treasure Award is Sue Allsup, District 8.

The youngest member present was Jaclen Meador, 26 years old, District 1, Dallam County.

The oldest member present was Velma Dearing, Age 91, District 2, Yoakum County.

Members & Clubs who were awarded certificates at their District Spring Conferences for 50/55/60/65/70/75/80 years were recognized. (Att.2)

Millie Barrow, TEEA State Treasurer presented a certificate to the new club, Rains County Garden EE Club, District 4. The award for the largest increase in membership went to Rains County EEA. The award for the largest percent increase in membership went to Denton EEA. CVU Awards were given by Gwen Risinger. (Att. 3)

Violet Alexander, TEEA Representative to the 4-H Foundation Board gave her report and announced the winner of the Adult Career Scholarship – Ashley Piercy, Scurry County, District 2.

The TEEA 4-H Scholarship winners were announced. Cathy Hanzik had presented these scholarships at 4-H Roundup this year. (Att. 2)

Kay Taylor, Second Vice President for Programs introduced the State Education Chairs, who each gave a short description of their workshops, to be presented Wednesday afternoon.

Grace Glaze, Alumni Committee Chair gave her Financial Report. (Att. 4)

Millie Barrow gave the 2012-2103 Financial Statement. The report will be filed for the Financial Review Committee. (Att. 5)

Carrol Davig, Budget Committee Chair presented the 2013-2014 Proposed Budget; the Proposed Budget was adopted. (Att. 6)
