Letter from Alby Peters, District 1, asking that we consider a state-wide project, in which members "Tie One On" one day each year in November, when members do volunteer work while wearing an apron from the past, and get publicity for TEEA, following the pattern of the 4-H One-Day event. She also asked that we engage Ellyn Anne Geisel for our keynote speaker at this year's conference. (Att. 2a)

Executive Committee Recommendations - Julie Neusch:

- (1) That "funds will not be issued to Education Chairs prior to the State TEEA Conference and signed receipts will be reimbursed by the State TEEA Treasurer up to a limit of \$500 each." Motion was and adopted. (Att. 3)
- (2) That "the committee be set up to investigate an investment of \$10,000 in something other than a CD which could yield more money and give them permission to carry out that change." Motion was tabled until tomorrow. (Att. 4)

- (3) That "TEEA no longer carry insurance through American Income Life Insurance Company or any other insurance company for TEEA meetings and the TEEA State Conference." Motion was adopted, and is effective immediately. (Att. 5)
- Monthly and Annual Reports Kay Taylor & Dr. Joyce Cavanaugh: Committee has been working on improving & streamlining the reports. After some slight adjustments, the new report forms will be implemented in the next reporting period, beginning Oct. 1, 2014.
- Outstanding Education County & Honor Roll of Counties Millie Barrow: Guidelines are being written for choosing winning counties, and will be included in the Manual.
- EIN's Millie Barrow has been filing for each club in the state, and will finish soon. Each District Director will receive receipts for the clubs in their respective districts. Next year each club, association & district will be responsible for filing their own 990-N.
- Emeritus Membership This will be included in the Bylaws after approval at the state conference.
- <u>The TEEA Messenger</u> Lela Goar gave the financial report for the Messenger. The balance as of May 5, 2014 is \$590.00. The last issue (Feb. 2014) was printed in color, which was the printer's mistake. They only charged for black & white since it was their error. Lela calculated that it would cost less than \$2.00 per year per member to continue publishing the Messenger in color. (Att. 6)

Also, clarify the need for the student to get their information to the TEEA Treasurer, and that the scholarship is from TEEA, not from 4-H. A sample letter for District Scholarships should also be added to the Manual.
- Concerning tabled motion from yesterday (Att. 4): Motion: Betty Baughn moved to amend the motion, that the investment should exceed the recommended \$10,000, and be increased to \$30,000. Motion was seconded and adopted. (Att. 10) Motion: Gwen Risinger moved that the motion to form an investment committee be amended so that the Investment Committee provides information to the Executive Committee, who chooses the investment. Motion was seconded and adopted. (Att. 11)

 Amended Motion: "That the committee be set up to investigate an investment of \$30,000 in something other than a CD which could yield more money. Investment Committee will provide information to the Executive Committee, who will choose the investment." Motion was adopted.
- Motion: Millie Barrow moved that "funds to support District-wide 4-H food and clothing related contests be submitted to the 4-H Foundation and monies be distributed to each District TEEA in equal amounts. Following District events an annual report to be submitted to the TEEA Treasurer describing how the funds were used. The TEEA Executive Committee will execute a memorandum agreement with the 4-H Foundation outlining management of TEEA funds." Motion was seconded and adopted. (Att. 12)

Goals from May 2013 reviewed – Cathy Hanzik: The Board has been working on all goals, but more needs to be done in all areas, especially Social Media & Recruitment of new members. It was decided that we need to formulate a short "Elevator Speech" that can be used when members are asked about TEEA. Cathy assigned board members who have time today to each write an "Elevator Speech", and they will be reviewed by the whole board before we leave this meeting. We'll keep working on all goals.
