TEXAS EXTENSION EDUCATION ASSOCIATION, INC. 87TH ANNUAL STATE CONFERENCE, WICHITA FALLS, TEXAS SEPTEMBER 9 AND 10, 2014

GENERAL SESSION, TUESDAY, SEPTEMBER 9, 2014

The 87th Annual State Conference was called to order by President Cathy Hanzik at 1 p.m. at the MPEC in Wichita Falls, Texas.

The Invocation was given by Julia Moseley, TEEA President-Elect.

Presentation of Colors was presented by the Sheppard Air Force Base Honor Guard. Pledge of Allegiance to the US Flag was led by Rosabelle Leal, District 1 Director, which was followed by the singing of "The Star Spangled Banner" and "God Bless America".

Pledge to the Texas Flag was led by Rosabelle Leal, followed by the singing of "Texas, Our Texas". The song leader was Rayanne Bowker, member from District 5.

Kaylene Layton, District 2 Director led the TEEA Creed and Mission, which was followed by the TEEA State Song – "Song of Peace". Kaylene Layton gave the Welcome from the North Region. Greetings and Welcome to Wichita Falls were given by Glenn Barham, Mayor of Wichita Falls.

The Credentials Report was given by Bess Farr, Education Committee Chair:

The Credentials Report was adopted. A quorum was established.

Secretary Julie Neusch, read the Rules of Conference, which were adopted by the assembly. The Conference Program was reviewed by Julie Neusch, with necessary changes made. The Conference Program was adopted as the order of business.

Cathy Hanzik appointed the Minutes Approval Committee - Edith Jones & Kay Taylor.

Cathy Hanzik appointed the Tellers - Betty Baughn, Ola Culwell, and Lynda French.

Cahty Hanzik appointed the Time Keepers – Clara Ball, Debbie Gillespie, and Joyce Morrow. Cathy Hanzik recognized Phyllis McMakin as Parliamentarian.

Delegate Responsibilities were reviewed by Julie Neusch.

Cathy Hanzik introduced the 2013-2014 TEEA Board of Directors, TEEA Past Presidents, TEEA Past Board members and TEEA Advisors Dr. Judy Warren and Dr. Joyce Cavanagh, Texas A&M AgriLife Extension Service.

The Memorandum of Agreement between TEEA and Texas A&M AgriLife Extension Service, which had already been signed by Dr. Douglas L. Steele, was signed by Cathy Hanzik. Dr. Susan Ballabina joined us on the big screen through video chat, and spoke about our partnership.

Second Vice President for Programs Kay Taylor introduced each District Director as they announced their Outstanding Education Counties and Honor Roll of Counties, and awarded certificates. (Att. 2)

Displayed on the screen were the two "Big Checks" representing the value of education, volunteer hours and scholarships given by members during the 2012-2013 fiscal year. The checks were in the amounts of \$105,826.21 for education reaching 16,957 people; and \$6,867,961.80 for 263,505 volunteer hours plus scholarships.

Cathy Hanzik recognized first-time attendees.

The Texas Treasure Award district winners & state nominees were introduced. The winner of the State TEEA Texas Treasure Award was Ollie Ann Baker, District 7, Burnet County.

The youngest member present was Tina Trevino, age 31, Calhoun County, District 11. The oldest member present was Velma Dearing, age 92, Yoakum County, District 2.

Members & Clubs who were awarded certificates at their District Spring Conferences for 50/55/60/65/70/75/80 years were recognized. (Att.2)

The award for the largest increase in membership went to Burnet County EEA. The award for the largest percent increase in membership went to Hidalgo County EEA.

CVU Awards were given by Gwen Risinger. (Att. 2)

Nelda VanHoose reported that there were no applications this year for the Adult Career Scholarship. Members are encouraged to try to get more applications for this scholarship in the future.

In the absence of Violet Alexander, Julia Moseley gave the 4-H Foundation Report. Violet is travelling, but sent her report for Julia to read.

Lela Goar, Messenger Editor, gave <u>The TEEA Messenger</u> Report. She thanked the ladies in Burnet County who help her get the paper ready for mailing. The total cost of the June Issue was \$2,803.07. (Att. 3)

The TEEA 4-H Scholarship winners were announced. Cathy Hanzik had presented these scholarships at 4-H Roundup this year. (Att. 2)

Grace Glaze gave the Alumnae Scholarship Report. There were six \$500 scholarships given this year by the Alumnae Committee. (Att. 2) The Alumnae Financial report was also given by Grace. As of August 12, 2014 there is a balance of \$3,103.25. (Att. 4)

Kay Jacob gave the TEEA Financial Report. Bank balance as of August 5, 2014 is \$41.977.02. The report will be filed for Financial Review. (Att. 5)

Lynda French, Finance Committee Chair, presented the Proposed Budget for 2014-2015. The Proposed Budget was adopted. (Att. 6)

Millie Barrow, Bylaws Committee Chair, read the **Proposed Bylaws and Standing Rules Amendments**, and moved adoption of each amendment one by one. (Att. 7)

Article XVI – County Association Chair – Section 1 – **MOTION** by Roseanne Keilers, Erath County to amend Article XVI, Section 1 by striking the words <u>and have held an office at Club level</u> and inserting <u>and have held the office of Chair or Vice-Chair at Club level.</u> (Att. 8) Motion failed. Original Amendment was adopted.

Article XIX – Finances – Section 5 – **MOTION** by Roseanne Keilers, Erath County to amend Article XIX, Section 5 by inserting after the word Treasurer <u>within 60 days.</u>

(Att. 8) Motion was adopted. Amended Amendment was adopted.

Standing Rules amendment was withdrawn by the committee.

Edith Jones, Resolutions Committee Chair, reported that there are no resolutions at this time.

In the absence of Nyanza Price, her sister Clara Jones gave her speech. Acting Election Committee Chair, Judith Finke introduced her Election Committee and reviewed the Election Procedures.

Announcements were made, door prizes were given, and the meeting was recessed at 5:20 p.m., until Wednesday morning.
