- The oldest member in attendance was Mabel Helton, age 93, from District 9, Montgomery County
- The youngest member in attendance was Sherry Williams, age 23, from District 5, Nacogdoches County.
- Ten members received CVU awards.
- The "Traveling Plaque" was won by District 7.
- Nyanza Price was elected President-Elect.
- Kay Jacob was elected First Vice President of Leadership.
- Ola Culwell was elected Treasurer.
- Three new District Directors were installed.
- "Elvis was in the house". Harvey McFadden gave an outstanding performance.
- Dr. Rick Peterson, Professor at Texas A&M AgriLife Extension gave an informative program "Healthy People - Healthy Communities" at our Lunch and Learn.
