2014 PROPOSED AMENDMENTS TO TEEA BYLAWS AND STANDING RULES

FOR 2014 STATE TEEA CONFERENCE APPROVED BY THE TEEA BOARD OF DIRECTORS MAY 2014 TO BE CONSIDERED AT THE 2014 STATE CONFERENCE IN WICHITA FALLS

IF ADOPTED, THE PROPOSAL WILL TAKE EFFECT OCTOBER 1, 2014

ARTICLE IV - MEMBERSHIP

Amend by Addition

Section 6. Emeritus Membership may be conferred upon a member who has been a TEEA member for 20 years or more if that member can no longer actively contribute to the club due to permanent, serious mental or physical disability. The title Emeritus may be granted by the executive board of a club. No state dues will be paid, but The Messenger could be purchased.

Rationale: To add membership status for non-active members of 20+ years.

Submitted by Bylaws Committee Recommendation: To adopt

ARTICLE V - OFFICERS Amend by addition

Now reads

No officer shall be elected to serve more than one term in the same office with the exception of the Treasurer, who may be elected to two consecutive terms.

If adopted will read

No officer shall be elected to serve more than one consecutive term in the same office with the exception of the Treasurer, who may be elected to two consecutive terms.

Rationale: To add the word consecutive to term limit of officers. Submitted by Bylaws Committee

Recommendation: To adopt

ARTICLE VIII - NOMINATION AND QUALIFICATION OF OFFICERS Section 1. Amend by substituting and striking.

Now reads

A candidate for state office shall be endorsed by the club, county and district in which membership is held. No candidate shall be presented who has not consented to serve. A club may not present a candidate until thirty days following the close of the TEEA State Conference. A candidate must be a current member of TEEA.

If adopted will read

A candidate for state office shall be endorsed by the club, county and district in which membership is held. No candidate shall be presented who has not consented to serve. A club may not present a candidate until thirty days following the close of the TEEA State Conference. A candidate must be a member of TEEA for at least 1 year and membership must be current.

Rationale: To clarify membership of candidate

To be eligible as a County Association Chair or Vice-Chair, a person shall have been a TEEA member for at least one year.

To be eligible as a County Association Chair or Vice-Chair, a person shall have been a TEEA member for at least one year and have held an office at the Club level.

ARTICLE XIX - FINANCES Section 5 - Amend by substituting and striking

All expenditures with receipts shall be submitted for reimbursement within 30 days to the Treasurer.

The 4-H Tech Wizards are youth from military and civilian families located at College Station, Georgetown, Houston, and Roscoe, Texas. Through Texas A&M AgriLife Extension Service, Mr. David Wright and his Tech Wizards Team have obtained a grant through the AARP Foundation specifically to help people 55 and older learn to use new technology.

Because the iPad is the most popular tech phenomenon, it will be featured in the educational lineup. The iPad was first introduced in 2010 and has been updated from first through fifth generation revisions. The "i" simply stands for "internet". The Apple founder Steve Jobs wanted a computer in a book that you could learn in 20 minutes, thus it was "born".

The mini iPad has a 7.9" screen and the iPad Air has a 9.7" screen. But the capabilities are endless. You can shoot video, take photos, play music, email, search the web, play games, use it for social networking and for GPS navigation. It has a virtual keyboard. There are thousands of Apps available.

The iPads range from about \$399 up and can be purchased from Apple stores, Amazon and Wal-Mart to name a few.
