### WHAT SHADOW DO YOU CAST

I've never felt that I was self-centered before, but in this job it seems to go with the territory. I, I, I, me, me, me, will you do this for me, will you do that for me. I really want to focus on the organization and the members. I'm speaking to you as the leaders or future leaders of our organization. I love being a leader in TEEA and other organizations, and I take that responsibility very seriously.

There is an old quote from author Robert Fulghum that sums up leadership, "Don't worry your children hear what you say, worry instead that your children are watching what you do!" As leaders our members are not listening to what we say but they are watching what we do. As leaders, we all cast a shadow and it's in this shadow that other members take their cues as to what to do and how to do it. What shadow are you casting?

Ralph Waldo Emerson said, "Who you are speaks so loudly that I can't hear what you're saying." Every leader casts a shadow. It is a simple, yet powerful concept that should resonate with every individual in a leadership position or anyone who aspires to hold one. The shadow of the leader is the phenomenon wherein leaders, through their behaviors and actions, project significant influence on those around them – thus "casting a shadow".

Larry Senn, in a 1970's doctoral dissertation said that over time organizations tended to mirror the character and style of their leaders. Leaders often tend to underestimate the length of their shadow – not necessarily understanding that their impact goes well beyond those that work directly with them and becomes part of the fabric of the broader organization. As a leader, you cast a shadow -- whether you want to or not.

As a leader every move you make is watched and often emulated by the people who work with you. They take their cues in terms of what is important from what you, as their leader, pay attention to how you react in various situations.

Most importantly, those who work with you will decide what behaviors are acceptable and valued based on what they perceive your priorities are. To achieve the engagement you want and to ensure you get the performance that you expect, you should be very thoughtful about the shadow that you cast. And if you don't like what you see, work deliberately to change it. It could be that your members are mirroring a misapprehension.

If a leader treats every setback as a failure, so likely will the members. If a leader looks to blame others when deliverables are not met, so will the members. If a leader does not show up on time for meetings, so will the members. If a leader arrives early and stays late, pretty soon, so will many of the other members.

If every request is regarded

as a fire drill, just watch how frantically the other members will begin to respond to the bell. If, on the other hand, you as a leader look at failure as an opportunity to learn, grow, and get better, other members will also. If you assume accountability and deliver on the commitments you make, other members will follow you. If you handle crisis in a calm and effective way, this approach will soon pervade the organization.

As I reflect on the shadow that I currently cast versus the shadow I would like to project, I know that I would like to empower others to demonstrate their strengths and abilities. The poem, "I'D RATHER SEE A SERMON" by Edgar Guest reflects some of my feelings about life.

I'd rather see a sermon than hear one any day.
I'd rather one would walk with me than merely tell the way.

The eye's a better pupil, and more willing than the ear, Fine council is confusing, but example's always clear. The best of all the preachers are men who live their creed, For to see good put into action, is what everyone needs.

I can soon learn how to do it, if you let me see it done, I can catch your hands in action, but your tongue too fast may run. And the lecture you deliver may be very wise and true, But I'd rather get my lesson by observing what you do. For I may misunderstand you in the high advice you give, But there is no misunderstanding how you act and how you live. When I see an act of kindness, I am eager to be kind; When a weaker brother stumbles, and a stronger stays behind. Just to see if I can help him, then the wish grows strong in me, To be as big and thoughtful as I know that friend to be. And all travelers can witness that the best of guides today, Is not the one that tells them, but the one that shows the way.

**NEW ORLEANS** — A team of five young 4-H chefs in extreme South Texas blew away the judges recently when they not only whipped up a delicious seafood dish in fierce competition, they explained that the ingredients they used were those of their ancestors who first inhabited the Americas.

"The 4-H Starr Chefs aced it," said Yolanda Morado, a Texas A&M AgriLife Extension Service family and consumer sciences agent in Starr County. "They took first place at the Great American Seafood Cook-off in New Orleans, beating out cooking teams from several southern states. I couldn't be more proud of them."

4-H is the youth component of AgriLife Extension.

The team worked long and hard to make it to competition in Louisiana, Morado said, having previously won competitions at local and state levels.

"In College Station at the annual State 4-H Roundup in June, the 4-H Starr Chefs competed against 4-H teams from throughout Texas," she said. "They placed among the top four finalist teams, then in the second heat won first place overall. That got us invited to the national competition."

The 4-H Starr Chefs team includes Janay Rocha, Garrett Gonzalez, Jason Gorena, Brandon Guerra and Crystal Alaniz. The team is coached by Roel and Rolando Hernandez, former Starr County 4-H'ers and owners of Elite Catering Service in Rio Grande City.

The team selected a delicacy known as seafood empanadas, or turnovers, to show off their culinary and presentation skills.

"The 4-H competition was an invitational," Morado said. "Only

top-winning teams from throughout the country were invited. We had already been invited to appear on the Food Network but couldn't because of conflicting schedules. But when we were invited to compete in New Orleans, I knew this would be good exposure for the team. They would compete among the best in the nation and would be judged by four top professional chefs."

The event was sponsored by the Louisiana Cooperative Extension Service 4-H division. To finance their trip, the Starr County team collected \$7,000 in six weeks.

"Starr County is said to be among the poorest in the country, but our community backed our team all the way," Morado said. "Most were small donations, but the entire community got involved. None of this could have been possible without the support of parents, coaches, businesses and citizens. They made sure our team had everything they needed to compete."

By the time the 4-H Starr Chefs competed in New Orleans, they were well-versed in addressing crowds and judges at many events, Morado said. For New Orleans, they had done their homework. But this was their first foray into national competition; many of the other competing teams had been there before.

"When judges asked about the ingredients they used, team members knew about sea life in the Gulf of Mexico, many from having gone on family fishing trips," Morado said. "And when asked about the vegetable ingredients, they very confidently told the judges about their culture and how the Aztecs, Incas and others had been the first to farm

corn, onions, tomatoes, peppers, cilantro and other vegetables. The judges were enthralled. They were very impressed."

For placing first, the 4-H Starr Chefs won a \$1,000 award and \$500 for traveling expenses. They were also treated to a tour of a seafood packing facility and a five-course meal of lobster and prime rib at Dragos, a five-star restaurant in New Orleans.

"It wasn't about the money," Morado said. "It was about competing against the best and taking the opportunity to let the world know about our proud Hispanic history and culture."

The chefs praised 4-H and their community for helping them gain confidence.

"This project has taken me from a timid and shy person to one who is confident and eager to meet challenges," said Crystal Alaniz.

Janay Rocha said, "My 4-H food challenge experience has given me a great appreciation for my community. The support we have gotten has been a blessing and has showed our team how committed they are to young people pursuing their talents"

Another, Garrett Gonzalez, said, "These 4-H competitions taught me how motivation and keeping the team composed and focused when facing adversity is very important."

And Jason Gorena said, "Teamwork was what brought us this far, to me it's not the value of one but the value of all."

The 4-H Starr Chefs have one more challenge this year: representing Texas in September at the National 4-H Food Challenge at the State Fair of Texas.

### 4-H STARR CHEFS TAKE NATIONAL TITLE IN DALLAS

October 1

DALLAS—The 4-H Starr Chefs kept their winning streak alive by sweeping the 4-H National Cooking Competition a the State Fair of Texas in Dallas.

"They've won it all. There's nothing more to win," said Yolanda Morado, a Texas A&M AgriLife Extension Service FCS agent for Starr County and the team's mentor. "For us, this is like winning the Super Bowl,

World Series and Wimbledon all in one."

To beat out 4-H cooking champions from as far away as Virginia, the Starr County 4-H'ers kept up their pledge of working hard to be the best, Morado said.

"Texas, Our Texas" sang out loud and clear as the theme for the 88<sup>th</sup> TEEA State Conference held at the Waco Civic Center in Waco, TX on September 15-16, 2015. With table decorations of yellow roses and Texas emblems all around we knew we were in this great state of ours. The program agenda had the TEEA state seal with a reminder of the added touch to the opened heart—we open our hearts to all.

For the 2-day convention we had 475 registered members, board, agents, advisors and guest attend. Having the
