




#### BELL EEA SCHOLARSHIP RECIPIENT SUCCESS STORY

Award in the distinguished
career category from the

Texas A&M AgriLife Extension Service.



Superior Service Awards recognize AgriLife Extension faculty and staff members who provide outstanding performance in Extension education or other outstanding service to the agency and to Texans. The award was presented Jan. 12 during the Texas A&M AgriLife Extension Conference awards dinner at the Brazos Expo Center in Bryan.

Dr. Bading has been with Extension for 29 years, beginning in 1986 as an assistant county agent for home economics in Guadalupe County. In her current role as a county agent, she develops and supports community coalitions and task forces addressing issues ranging from childcare to nutrition, health and wellness. In her award nomination, Bading was also cited for her work with nutrition, child care, diabetes education, health and wellness. One of Bading's major accomplishments cited was her support of the Better Living for Texans program, through the "Six Easy Bites" and "Get the Facts" series curricula, as well as "MyPlate Food Groups" and "Back to the Basics" programs.

Since 2011 Dr. Bading has also worked extensively with the Child Care Conference Task Force since 2011 to provide quality educational training for child care providers, and since 2013 has trained providers and directors who give care to 4,375 children enrolled in 68 child care

centers or family day homes. A total of 1,850 clock hours of training were provided to childcare professionals seeking to meet state-mandated training established by the state of Texas.

With assistance from the **Diabetes Education Task** Force, Bading also has been instrumental in organizing and delivering diabetes education through the "Do Well, Be Well with Diabetes" program. In 2013 and 2015, a total of 103 people with diabetes participated in the classes offered with 69 reported never previously having diabetes classes. According to her nomination, Dr. Bading also has collaborated with numerous agencies, organizations and educational institutions, as well as various charitable and human service organizations. Some major partnerships/ collaboration efforts over the past several years include: the Institute for Public Health and Education Research Inc.. Resolute Care Active Living Coalition, the Child Care Conference Task Force, Diabetes **Education Task Force and** Dinner Tonight! Task Force.

During the time Dr. Bading served as a regional program director and district 4-H specialist, she partnered with numerous county Extension agents and subject matter specialists to plan and deliver high-quality educational programming to 4-H members and adult volunteers. She


