After many hours of waiting patiently in the lobby of the nursing home, she smiled sweetly when told her room was ready. As she maneuvered her walker to the elevator, I provided a visual description of her tiny room, including the eyelet sheets that had been hung on her window.

I love it," she stated with the enthusiasm of an eight-yearold having just been presented with a new puppy. "Mrs. Jones, you haven't seen the room, just wait."

"That doesn't have anything to do with it," she replied. "Happiness is something you decide on ahead of time. Whether I like my room or not doesn't depend on how the furniture is arranged... it's how I arrange my mind. I already decided to love it. "It's a

decision I make every morning when I wake up. I have a choice; I can spend the day in bed recounting the difficulty I have with the parts of my body that no longer work, or get out of bed and be thankful for the ones that do.

Each day is a gift, and as long as my eyes open, I'll focus on the new day and all the happy memories I've stored away—just for this time in my life. Old age is like a bank account: you withdraw from what you've put in.

So, my advice to you would be to deposit a lot of happiness in the Bank account of memories. I believe that I will be just happy as I make up my mind to be. Thank you to the whole state for your part in filling my Memory bank. I am still depositing.

I loved the TEXAS theme in Waco last year, and I'm just as excited about the BUTTERFLY theme this year in Plano. I'm very excited about the State Conference on September 13 &14. It will be really great. Everyone is working very hard to make it a success. Financially, the hotels are less expensive and registration is \$10 cheaper. 

# **GREETINGS FROM COLLEGE STATION!**

I am writing this article to meet a June 1 deadline to Lela! While June 1 is an important milestone to the Messenger, it's even more important to many Texans because it marks the beginning of hurricane season. If you live along the coast, in a county inland from a coastal county or in an area where hurricanes have historically tracked, you know the importance of planning for disasters and emergencies. But, all of us should take the task of planning for emergencies and unexpected disasters seriously.

Recently at a meeting of the State Emergency Management Council at the State Operations Center in Austin, Nim Kidd, Chief of the Texas Division of Emergency Management, shared statistics about the prevalence of disasters in Texas. Texas ranks #1 in the incidence of federally declared disasters in the nation over the last several decades. This is not an area we want to be ranked as #1. but one where we have no say. The most common disaster has been flooding, which can affect anyone no matter where they live! Damages from these disasters have totaled in the billions of dollars. Unfortunately, recordbreaking rainfall in May has given us flooding in several parts of the state - adding to our long history of disasters. At the 2015 State Conference, the Evacuating for Emergencies program was introduced. If you haven't had

this program presented to your club or county association, ask for it. Consider offering it in your community as a public service. In addition, AgriLife resources are available on our website at http:// texashelp.tamu.edu to assist in preparing a disaster supply kit and a Grab and Go Box for financial records. Our After a Disaster publication is a compilation of our fact sheets with information on recovering from a disaster. In the AgriLife Bookstore, www.agrilifebookstore.org, you'll find publication EF-CS005. Personal and Family Financial Records Inventory, a downloadable pdf file for recording information about your financial accounts and other helpful information. You can add these publications to your supply kit. Many of these resources are available in ebook format that can be downloaded to mobile devices which makes them easily accessible when needed during or after a disaster.

Many of us have escaped being directly impacted by the current flooding, tornadoes, and other damages from the rains, but we may not escape the next disaster. To borrow a phrase from Scouting, Be Prepared! And help your neighbors Be Prepared. There's no better time than now!

New U.S. Dietary Guidelines
Based on the most recent science, the 2015-2020 Dietary
Guidelines for Americans
were released at the beginning of 2016. Before you say,
"here we go again," let's take a closer look. The guidelines may sound familiar, but there are some differences from years past.<sup>1</sup>



Overall guidelines. For the most part, these guidelines don't advise you about how much to eat of different foods, such as vegetables or meat. Instead, they focus on helping you fit healthy eating into their own unique lifestyle. To that end, they provide three examples of healthy eating plans: a healthy American diet, a Mediterranean-style diet, and a vegetarian diet.

What these three types of di-

What these three types of diets share is an emphasis on more plant-based foods, healthy fats, and whole grains. The guidelines also suggest making meals and snacks from scratch. That helps avoid the common pitfalls of processed foods, such as high levels of salt and sugar

Overall, a healthy eating pattern includes:

- Any vegetable, but preferably a wide variety
- Fruits, especially whole ones
- Grains—with at least half being whole grains
- Fat-free or low-fat dairy
- A variety of protein sources, including seafood, lean meat, poultry, eggs, beans, peas, nuts, seeds, and soy products
- Oils<sup>1</sup>

Specific guidelines. The last set of guidelines came out in 2010. They simply advised people to reduce their intake of added sugars, without giving numbers. The newest guidelines, however, are more specific. They suggest you limit added sugars to fewer than 10 percent of your daily calories. Right now, added sugars account for more than 13 percent of Americans' daily calories. <sup>1</sup>

Soft drinks, fruit drinks, sweetened coffee or tea, flavored waters, and alcoholic beverages account for nearly 50 percent of all added sugars we consume. A recent study revealed that people who drink sugary drinks daily tend to put on more deep belly fat over time.<sup>2</sup> That's the kind of fat that surrounds vital organs and is linked to type 2 diabetes and heart disease. Other sources of added sugars are snacks and sweets, as well as foods like bread and prepared meals.

The new guidelines also suggest that you limit saturated fats to no more than 10 percent of your daily calories. That's a goal that fewer than a third of Americans meet. Sadly, these fats can increase levels of bad cholesterol, and your risk of stroke and heart disease.4 About a third of saturated fat comes from prepared foods containing cheese or meat-foods like burgers, tacos, and pizza—as well as dairy products, snacks, and sweets. Finally, the guidelines advise eating fewer than 2,300 milligrams per day of salt—a little less than a teaspoon. That's a guideline that nearly all Americans are failing to meet. But it's not something to ignore. That's because too much salt can increase blood pressure, which also increases risks of heart disease and stroke.

# EASTLAND COUNTY MORTON VALLEY EE CLUB LUNCH AND LEARN "EAT WHAT YOU GROW"

Millie Barrow put on her hat and gloves for the recent Lunch and Learn Program, taking this state program another step by presenting gardening and preserving information. The quarterly program is one of the community projects presented by the Morton Valley EE Club with support from the AgriLife Extension Service.

She presented "Gardening Tips for Beginners" and the hat was to remind everyone the importance of protecting yourself from the sun while working outside. The gloves were for sun protection aw well as other hazards to the hands while gardening. She also suggested wearing long sleeves and sun screen as well as planning your work time early in the morning when it is cooler and the sun is not so intense. The presentation revolved around tips to help create a more productive and low maintenance vegetable garden, i.e. space, preparing the soil, design and planning, mulching, watering, and many more.

Millie also presented a drawing of a "Keyhole" garden designed by a lady from Cisco. It is a raised garden built in a circle with a V-shaped area to stand in to weed, water or harvest. Raised beds make it easier for a person to tend to without having to bend or squat.

To address the question of what to do with your bountiful harvest Millie spoke about canning foods safely at home. She gave pointers for using a pressure canner or water bath canner depending on the types of vegetables or fruit. She cautioned that you need to refer to your canning book as to instructions on preservation and storage of canned products.

An interesting display of old and new pressure cookers, canning utensils, and a variety of canning books was set up for all to see. It is important to check the dial gauge on pressure cookers each year and it can be done at your local AgriLife Extension office.

Other displays included dehydration, vacuum sealing for freezing, jars of canned vegetables, jams and jellies. Different club members shared ideas and where they learned to preserve and can foods.

The presentation followed a buffet of delicious salads, breads, crackers, spreads and desserts prepared by members of Morton Valley EE Club. A fun drawing for all sorts of interesting and useful garden and household gadgets and jars of homemade jellies closed out the program.

The Morton Valley EE Club meets the second Thursday of each month at the Senior Building on the Hill in Eastland. The meetings are open to the public.

Something all people who have a cell phone need is the following information in their phone number list: ICE. This is a code word for "In Case of Emergency" where the ambulance, firefighters, police, sheriff or other law enforcement agencies can go on your phone to call a designated family or friend to get information or authorization for health care to you if you are hurt and not able to speak. Also, Clara gave us a website, www.drivetexas.org, to help with evacuation routes, accident rerouting, etc. Another important step for us to take is to register with the 211 phone #. This number is for any special needs population who may need help in an emergency situation.

The 4<sup>th</sup> speaker was Michaelene Perry who discussed preparing the presenter. If you have ever attended a talk or class and the presenter was really boring...you know what it means to be prepared. All the good points of a lecturer are: keep the topic interesting for the audience with the use of humor, talking clearly and at the audience level, using materials that are relevant, such as handouts, slides or Power-Point sources, or hands on activities.

The final topic was presented by Laura Petty, our new 4-H & Youth Development Agent. With over 8 years experience with 4-H and youth programs, she discussed "Judging 4-H Projects." The EE Clubs in Leon County work with 4-H students by providing scholarship funds to graduating seniors, and some EE members have family relative (grandkids, nieces, nephews) who are 4-H active
