### **EXECUTIVE BOARD OFFICES 2017-2019**

We have several Executive Board offices to be filled for 2017 – 2019:

#### PRESIDENT-ELECT FIRST V P OF LEADERSHIP TREASURER

As stated in our bylaws, **Article VIII**, Nomination and Qualification of Officers: **Section 1**.

A candidate for state office shall be endorsed by the club, county and district in which membership is held. No candidate shall be presented who has not consented to serve. A club may not present a candidate until thirty days following the close of the TEEA State Conference. A candidate must be a member of TEEA.

Two weeks prior to the District Spring Conference, a club presenting a candidate shall notify in writing the County Association and the District Director, giving the name and qualifications of the candidate for the particular office for which presented. The endorsement must be signed by the president and secretary of the club. Candidates must also be endorsed by the county association to which they belong prior to the District Spring Conference. The County Association Chair shall

notify the District Director in writing.

A majority vote of the Delegates at the District TEEA Spring Conference at which the election is to be held shall constitute the endorsement of the district. The District Director shall notify in writing the TEEA President of any endorsed candidate by May 1.

#### Section 2.

To be eligible for the office of President-Elect, a candidate must have served at least one year as a member of the Executive Committee.

#### Section3.

To be eligible for the other state offices, candidates must have served at least one year as an elected or appointed District Director or Education Committee Chair.

#### Section 4.

A candidate for Treasurer shall be eligible for bonding, knowledgeable in bookkeeping, and familiar with long and short term investments.

#### Section 5.

To be eligible for the office of District Director-Elect or District Director, a candidate must have served at least one year as County Chair or Vice Chair. **Section 6.** 

Nominations from the floor may be made only by a member of the same county association as the person nominated. The nominee must meet the same qualifications as other candidates. Written notice of a proposed nomination from the floor shall be given to the President prior to the session in which nominations are in order. Eligibility for nomination from the floor at the TEEA State Conference is not affected by the May 1 deadline.

Also, please read Chapter 9, page 2 – Declaring Candidacy for State Office.

Please abide by these two rules.

Remember, these are important positions to be filled. Make sure your candidate is qualified.

## NOONTIME WINS AT WILLIAMSON COUNTY ANNUAL AWARDS DINNER

By Charlotte Watson At the 2016 Williamson County Awards program, Noontime EE Club won the Special Projects Award for their long-term involvement in "Stamping Out Literacy." This included a small monetary award which the club will put back into community projects.

Literacy projects have included "First Book for New Baby" initially begun with new baby books given to each new baby born at Georgetown Hospital. This year, books have also be given to moms and babies at the Pregnancy

Help Center, Annunciation Maternity Home, and to the children at Head Start. Last February, three Noontime members went to Head Start and read several books in each of the 3, 4, and 5 year old classes.

Another countywide project has been to donate good, used paperback books to Project Better Chance, a program of the Literacy Council of Williamson County at the Williamson County Jail. Over the years, Noontime has donated 1,800 paperback books plus another 100 dictionaries and resource books.

Another successful Noontime literacy project has been a partnership with the Austin American-Statesman. What began as a \$150 per year cost for a classroom to get 25 copies of the newspaper one day each week has grown to a cost of \$300 per year for the entire school to get an electronic edition of the Statesman each week. One teacher said. "having the newspapers available to use in math, history, English/literature, and science classes has really helped with our state-required curriculum."

This year, Noontime also donated 100 paperback and hardback books to help begin a new library at a new senior adult long-term care facility, The Dulaney.

The current statistics on illiteracy in Williamson County are still staggering. Have we made a difference? We believe we have, beginning with the youngest children, challenging the mothers to begin reading to their babies from the day they are born, to local school children, and to the senior citizens.

Our best conservative estimate is 300 hours donated plus \$6,750 spent. This includes time spent in raising the funds especially to support the Partners in Education (PIE) with the Statesman, purchasing books, delivering them to the "First Book" coordinator, delivering books to the jail and senior adult facility and delivering books and reading at Head Start.

At Williamson County's Annual Awards Program, an outstanding volunteer is honored from each club, selected by that club's members. Mary Johnson was honored by the Noontime EE Club as their Outstanding Volunteer for 2016. Mary is not only the club treasurer, but she is an active club member, helping to make this club successful in everything they do ,both in the community and in countywide activities and events. In particular in 2016, Mary led the club's proiect of making wreaths for their club's donation for Homemade Holidays. She invited the club members to her home to make the wreaths plus fed them delicious pulled pork sandwiches she made from scratch! Also this year, she went with two other club members and read to preschoolers at Head Start. When Noontime hosts their annual Christmas Luncheon and Silent Auction, you can count on Mary Johnson to bring the most delicious homemade foods plus make many creative crafts to sell at the Silent Auction. Mary also wins many ribbons at the County's Exhibition Day - both for foods and crafts. Creative, dependable, involved, and always present are just a few of the words that describe this Outstanding Volunteer!

Following are the winners and their recipes of the first place winning pies:



#### TRADITION PECAN PIE:

Cvndee Groce

- cup granulated sugar
- Tbsp. brown sugar
- tsp. salt
- cup corn syrup ( light or dark)
- 1/3 cup melted salted butter
- tsp. vanilla
- 3 whole eggs beaten
- cup heaping chopped pe-1 cans
- 9" unbaked pie crust

Preheat oven to 350 degrees. Mix the sugar, brown sugar, salt, corn syrup, melted butter, vanilla and eggs together in a bowl.

Pour the pecans in the bottom of the unbaked pie shell. Pour the syrup mixture over the top. Cover the top and curst lightly/ gently with foil. Bake the pie for 30 minutes. Remove the foil and then continue baking for 20 minutes, being careful not to burn the crust or pecans. The pie should not be over jiggly when you remove it from the oven (it will jiggle a bit). If it shakes a lot, cover with foil and bake for an additional 20 minutes or until set. Required baking time seems to vary widely with this recipe, sometimes it takes 50 minutes, sometimes it takes 75.

#### **DERBY PECAN PIE**

Millie Barrow

- 1/4 cup butter, softened
- cup sugar
- eggs beaten
- 3/4 cup white Karo syrup
- 1/4 tsp. salt
- tsp. vanilla
- 1/2 cup mini chocolate chips
- 3/4 cup pecans whole or chopped
- Tbsp. Bourbon

Preheat oven to 350 degrees. Cream butter and gradually add sugar. Add beaten eggs, syrup, salt and vanilla. Stir in bourbon. Add chocolate chips and pecans. Pour into unbaked 9" pie crust and bake 45 to 50 minutes. Use a pie crust ring if the crust starts getting too brown. The middle of the pie will jiggle a little. Best served warm garnished with ice cream.

## THE IDLE AMERICAN Education at a Gallop... Commentary by Dr. Don Newbury

**They're mere** "blips" on the screen of educational innovation, now in a handful of major cities. Their name sounds like a house number, and youngsters therein are challenged to "dig deep" as a core of teachers--largely volunteers--help children 6-18 express themselves through--of all things--writing.

These store front centers (for want of a better word) are attention-grabbers, front to back. "826," after all, isn't a usual name. The first was San Francisco's 826 Valencia St. It opened in 2002. If passers-by aren't "grabbed" by the numbers, small letters on the sign help. It reads: "independent pirate supply store."

After all, there aren't many such Yellow Page listings there, or any place else....

**What goes** on at "826s" mostly are projects to hone writing skills. Is it not interesting that such a concept seems to be bubbling again to the top, even if not yet to full boil? (There are actual sales--ie, pirate supplies--with all profits accruing to the non-profit project.)

"826s" are staffed largely by volunteers who realize the importance of written expression. They now have 1,400 such volunteers in San Francisco serving a minimum of one hour weekly. Simply stated, there is no app for that....

**The concept** is described as being to education what St. Jude is to hospitals. All children served pay nothing--it's free.

In the past dozen years, "826" centers include NYC (superhero-themed); Ann Arbor, MI (robots), Seattle (space travel supply) and Boston (Bigfoot Research Institute). Similar programs are offered in Great Britain and Dublin, Ireland. Dublin's is called "Fighting Words."

I'll stop "rat now," mostly because I know so little about "826." It seems to me, though, that retirees--particularly educators--might be interested. The concept seems both helpful and doable....

I trust the mentors bear down on the importance of careful note-taking. Throughout life, I have trusted scribbling on paper scraps, making "mental notes" and tying string around fingers. Reminders of painful experiences resulting from failures to remember are frequent and vivid.

Another one has been added to the list--instructions from the carpet store concerning what needed to be done prior to installation. I jotted down something about TVs/electronics/ knicknacks. When the inevitable day of discernment dawned, I THOUGHT this "note to self" meant they'd move these items. I reasoned, obviously, that we'd need to arrange furniture removal.

We hired three husky high school footballers, and in just two hours, they had furniture piled high in the garage, bathrooms and tiled areas.

Alas, I remembered instructions backwards. The installers usually remove the furniture, but don't handle TVs, electronics and knicknacks. They laughed about my mistake, then turned serious upon realization there was no entrance through which to bring in the carpet....

Probably the installers have "seen it all."

Upon seeing the entrance hallway "stacked up" in a manner to challenge the most slithery of snakes, the workers shook their heads. The same was true for the garage.

What to do? "We'll remove a window, roll up the carpet and shove it through," one of the guys suggested. Head-shaking changed to hand-shaking....

**It is** finished. After the furniture was back in place, we surveyed dozens of boxes in the garage. When they are emptied, cars can be returned to the garage.

Maybe we'll throw away half of the "stuff." Up the way, our children likely will toss 90-95% of it in the same manner.

For now, though, we're enjoying the "feel" of new carpet between our toes. No doubt, my enjoyment will be enhanced when Brenda allows me to remove those protective gauze shoes the installers left behind. And I'll "whoop it up"--maybe even squeal--when my computer mouse turns up. Man of faith that I am, I expect to see it again, and soon....
