This is a new position and the State Treasurer will no longer be responsible for the 990s, if approved. We are hoping this will help solve our current problems. If you have experience in filing 990 epostcards, are reliable, want to work hard and are an individual who will stay at it until an answer is received, and able to work without constant supervision, then please notify your District Director. The District Director will inform the State President of anyone interested and they will be interviewed for the position by the Executive Committee. This will be a position appointed by the TEEA State President.

We have three positions open on the Executive

Committee: President-Elect, First Vice President of Leadership, and State Treasurer.

We will also have some Manual changes which will be online after the State Conference. Your District Directors will have all those changes to report to the County Chairperson after our November State Board Meeting.

Several members have stated that a position on the TEEA Board would cost them personally. TEEA pays for travel expense to the Board Meetings (May and November) in Brownwood and also to the State Conference. Room and meals are paid for by TEEA at Brownwood as well as registration fee, rooms and meals (breakfast, Alumnae luncheon and banquet) at the State Conference. All of us are volunteers of our time. energy and leadership. TEEA is a wonderful organization for teaching leadership - for fellowship – for making friends for life.

We always have a need for District Director-Elects. It seems there is always a shortage. We currently have some Districts without a Director-Elect. If you have been a County Chair or Vice Chair, please consider this position. Surely you are curious as to what happens at our Board Meetings. Become a District Director-Elect and find out!

MAKING YOUR TEEA QUILT

I was recently asked to speak at the District 3 Spring Conference in Decatur. District Director Dixie Range told me their theme was *TEEA Time*. And although she told me I could talk about anything I wanted, I wanted to talk about something meaningful to the group. Like many of you, I do my best thinking when my hands are busy; so, one afternoon as I was working in my sewing room I got to thinking about how TEEA is like a quilt.

A quilt has 3 layers; the top, the middle - batting, and the backing.

When you look at a quilt you first see the quilt top. This is the public side of the quilt - what everyone sees - the public perception if you will. Individual blocks make up the top - the individual blocks in the TEEA quilt are all of you - the members, your clubs, your county associations, and district associations. They are your actions, your events; the part of TEEA that the public sees.

The quilt back provides the finishing - it may be beautifully plain in comparison to the top or it may be intricately complimentary to the top. In our TEEA quilt the backing represents those who work behind the scenes - your club officers, county and district association officers, the State Board and officers, committees, CEAs - all of the people who work to provide substance to the organization.

Now let's look at the middle of the quilt - the stuffing or batting. These are those things that give body, warmth and strength to our TEEA quilt. The quilting stitches and quilt binding holds everything together. Your mission, vision, and creed serve this purpose. Think of the binding as the social, personal and emotional support you give each other and your communities.

So, yes, this is TEEA time! It's time to decide and recognize where your strengths are. How can you as individuals, clubs and associations make a contribution to TEEA at whatever level of the organization you feel comfortable? How and where do you fit within our TEEA quilt? Leg-Pulling Long Gone...

Back in the 20th century, kids--as well as adults who sometimes acted like them--seemed destined to "make their own fun." Not too much in the way of "time-passing" was in play if it cost anything, thus fertile minds were often in "creative mode," if only in the sharing of jokes and stories.

Many times conversations began with, "Did you hear the one about...?" Sadly, these words rarely are heard anymore.

My old daddy could tell stories with the best of 'em, and he'd laugh as heartily as hearers at "punchline time." Clearly, such banter lessened the cares of the day.....

Much "fun-poking" came at the expense of youngsters. They took most everything seriously from adults who'd "been there, done that."

Carpenters took advantage of apprentices, often asking them to retrieve make-believe items. Such requests seemed legitimate to the eager-to-please, wide-eyed youngsters. A carpenter, sawing away, exclaimed, "Dad blame it, I sawed this board an inch too short. Would you please run down to the lumber yard and borrow their board-stretcher?"

The youngster immediately headed downtown. He returned empty-handed, telling the carpenter that the man at the yard had "loaned out the board-stretcher, and it's not due back until tomorrow." (The guy was, of course, in on the joke, and played along.)...

There was a whole 'nother category for the military, what with a steady inflow of recruits to send hither and you on aimless tasks. Many wandered around military bases seeking keys to the parade grounds.

Not every installation had parade grounds, and those that did rarely had fences. And if they had fences, the gates were never locked....

Ask locals in resort areas if you'd like to be regaled by dumb questions they've fielded from tourists on first visits to distant locales. One "flat-lander," amazed upon first seeing mountains, asked, "Reckon where they came from?"

When the local answered that the glaciers brought them, the visitor countered, "Where are the glaciers now?"

The local's answer: "They've gone back for another load."...

Lonn Taylor, a recognized author/historian/columnist who traded in life in Washington, D. Present were nationally-recognized figures from TV networks, wire services and major newspapers. Hallie asked just one question: "Now you fellows don't really think you're going to walk on the moon, do you?"...

Much has been made lately of "fake news." It has been around for quite a spell. As a lad, I wondered about blaring claims that seemed largely unsubstantiated.

For several years, an over-the-counter elixir called *Hadacol* was heralded as a cure-all for everything, as were "uranium-sitting" emporiums that attracted sitters from far and wide to claim the magical cures. Two centers where ailing folks sought magical sand in which to sit were in Marlin and Mineral Wells. (In the latter city, many "sitters" also soaked in the mineral water for which the community is known.)

I never knowingly swallowed *Hadacol*, or sat in sand beyond the boxes, but many friends did. Bottom line, there may not be much truly new under the sun....
